**Subject: Nomination of 'Maker' and 'Checker' for PM VIKAS Portal – Request for Details - reg.**

This is in reference to this Ministry's earlier communications regarding the launch and implementation of the Pradhan Mantri Virasat Ka Samvardhan (PM VIKAS) scheme. In this connection, I am directed to say that the PM VIKAS is a centrally sponsored scheme of the **Ministry of Minority Affairs**, aimed at the socio-economic empowerment of minority and artisan communities across India. It consolidates five earlier schemes—Seekho Aur Kamao, USTTAD, Hamari Dharohar, Nai Roshni, and Nai Manzil—under a unified framework. The PM VIKAS has the following four components:

- Skill and Training Component (earlier Seekho aur Kamao, USTTAD and Hamari Darohar)
- Women Leadership and Entrepreneurship (earlier Nai Roshni)
- Education Component (earlier Nai Manzil)
- Infrastructure Development Component

2. In continuation of the efforts toward the effective implementation of the scheme, a **workshop was organized on 15th April, 2025 at SCOPE Complex, New Delhi**, with officials/representatives of Skill Department from all States/UTs. The workshop was conducted in hybrid mode—both physical and through **Video Conferencing**—and served as a platform to apprise the States/UTs of the core components and objectives of the PM VIKAS Scheme. A copy of Scheme Guidelines of PM VIKAS is also enclosed herewith.

3. It is hereby informed that the **PM VIKAS Portal** has now been made operational for the purpose of **inviting project proposals** from States/UTs under the scheme. The functionality for submission of proposals by State/UT-level authorities is now live on the



portal. To facilitate this process, it is essential to onboard designated users from each State/UT onto the system.

4. In this regard, it is requested that each **State/UT** may kindly **nominate two officials from the skill ministry/department**:


- ii. One as the '**Maker**', who will be responsible for entering proposal-related data and documents on the portal; and
- iii. One as the '**Checker**', who will be responsible for verifying and approving the submissions made by the Maker
